The work generally consists of: the maintenance, repair, and rehabilitation of various apron, runway, and taxiway systems. The repairs include crack sealing, partial- and full-depth patch repairs, milling and overlay, drainage inlet repairs, HMA/PCC interface repairs, concrete apron crack and joint repair and slab replacement.
